Club Assembly

Club Service Committee - Greg McLeod

This Committee has met on one occasion in the two months since the last Club Assembly, with a further meeting to take place tonight following this meeting.

There is little to report to this Assembly other than to say that the Committee remains open to hearing any concerns from members of the Club as to the functioning of the Club and welcomes any constructive criticism.

The Committee remains of the view that a Secretary's report on matters of interest to members flowing from Board meetings should be given as a spot as soon as reasonably practicable following each month's Board meeting. This is important for good and effective communication within the Club on matters of importance to all members.

There is an ongoing need for rosters to be kept up to date and circulated for the information of members so that timely notice can be given of Club activities. The Bulletin is just one means of distributing information and it will be of tremendous help to the Bulletin Editor if roster details are provided several weeks in advance to that person.

Bob Mullins as the Committee's representative on the Thrift Shop Committee continues to watch over this Committee's obligations to the Thrift Shop Committee.

As previously advised, a review is still within contemplation of the existing Manual of Committee Responsibilities prepared in the previous decade with a view to assisting incoming Chairpersons of committees and sub-committees to better understand the obligations and responsibilities attaching to those offices within the Club. Thrift Shop - John Russell on behalf of Bob Laws

A Suggestion Box has been installed and 7 suggestions to date:

- Advertise and hold a \$2 clothing sale (we will hold a sale on 21/4/07)
- Don't sell cancelled library books (we will only retain the very best).
- The emergency list needs updating (Glenys/Sheila are attending to this).
- Fix the carpet sweeper or get a new one (we will).
- Ensure adequate supplies of tea/coffee/biscuits/sugar (we will).
- Put Mitcham Rotary Bookshop contact details by the phone (we will).
- Remove empty jewellery boxes from display case after sales (we'll ask).

Rent Increase. The landlady has agreed to our CPI calculation and the monthly rent from February is \$2,230.22 (not \$2,405.84)

OH&S. The landlady asked for estimated costs for fixing the emergency access and a letter has been sent advising her (it's about \$320).

Gross Income for March was \$4,483, and the year to date \$42,317 (compared to \$40,109 last year and \$55,225 in 2003/04).

Repairs: The shop front picket fence has been repaired by Bob Mullins.

Mavis has produced a cleaning duty list for the Saturday Rotarians.

Natalie will locate goods pick-up volunteers.

Three responses to the <u>ad for volunteers</u> which Sheila us following up. The volunteer charter is complete and on the shop noticeboard. Glenys/Sheila will update the roster and create a spreadsheet database by contacting all volunteers to ask:

- for their comments and concerns
- to confirm their time slots
- emphasise their importance to the shop
- availability as emergency replacements
- confirm their contact details (inc. email addresses)
- ask if they could recommend any new volunteers
- when they started as a volunteer with us.

A <u>morning tea for volunteers</u> will be held on 3.6.07 (Ken & Sheila will organise), hopefully in the Council facilities. Framed appreciation certificates will be presented to volunteers with 5+ year's service.

The <u>new roster</u> will include both Saturday and weekday volunteers. The rosters on the Club website are very out of date. Stephen will be requested to allow access to the website so Sheila can keep the rosters up to date.

<u>PR</u>: Kevin Rogers has negotiated a special 'one-off' price to include a shop flyer in the Eastern Courier. Bob Laws will get a quote for printing 25000 A5 size to be done up in bundles of 200. A more complete wording flyer has been prepared for shop use (for tucking into customer bags).

<u>Electrical goods testing</u>: Martin Cooper is very keen for the Club to purchase an electrical equipment tester (at a cost of \$600 approx.) instead of being charged \$3/item by Ivesons for no more than 5 tests per week. The committee decided to defer a decision while seeing how many appliances are donated and we have



some sales experience on which to base a cost/benefit decision. The very cheap price of new Chinese appliances will now be affecting the second hand market price and saleability.

Summer Sale. The ½ price sale of summer clothing was held on Saturday 21/4/07). Summer stock will be sorted, the best retained and the remainder disposed of and the winter stock brought out.

A request is made to have members' names, phone numbers and email addresses included in the weekly Bulletin (but not addresses for security reasons).

Treasurer - David Payne

Copies of figures for the 9-month period to 31/03/07 were distributed at the meeting.

These figures were tabled at the last Board meeting and show total assets at the end of March of \$120,287.67. If we ignore the funds that have gone into the Charitable Trust Fund our assets have decreased by about \$4,500 so far this year.

Details of income and expenditure for the various committees can be obtained from the Project Transaction Listing Sheets.

Tonight I want to focus our attention on the Thrift Shop with some updated figures.

At the last Club Assembly I indicated that the nett profit for this year should be similar or slightly higher than last year (say \$23,000 – \$25,000).

During April we received some rather substantial bills from our Landlord and it turns out that last year we were not invoiced for 2 quarters of water rates or any building insurance. These costs plus some costs for the Volunteers' morning tea have been carried over from last year adding about \$2000 to this year's figures.

Last year the nett profit for the 10 months to the end of April was approx. \$17,700.

This year for the same period our Income has increased by about \$2,300 but our Costs have increased by about \$5000 – a nett profit decrease of about \$2,700.

This means the nett profit for the 10 months to 30/04/07 is around \$15,000.

Last May and June were both good months lifting our profit by about \$5500 to show around \$23000 for the year (inflated by \$2,000 as shown earlier).

If we can continue at our current rate the likely nett profit for this year will be in the \$18,000 to \$19,000 range (deflated by the above \$2,000).

In other words, if we consider like for like, we are virtually covering our cost increases and returning a nett profit of around \$20,000 to \$21,000 per year.

General Business

Club Raffle. Joan Reed raised concern over the administration of the recent club raffle particularly in relation to the Lotteries act. A number of requirements were omitted and her own tickets were not included in the raffle. Following discussion it was agreed that all future such fundraising events which may depart from our normal activities would be passed to the audit committee for scrutiny.

Men's Shed Project. Jerry Casburn requested feedback from the club on the planned project to provide, via the Baptist Church Edwardstown Bloke's Shed, services for Unley residents. The club endorsed further work on evaluating the costs and benefits of the project for later presentation to the club. Requests were made to extend the project to include all age groups. This will now be referred to the Community Service Committee (2006/7 and 2007/8) for consideration.

The reports from International Service – John Peacham, Fund Raising – Greg Love, Rotary Foundation – Mavis Martin will be included in next week's bulletin.

Council on Legislation

Detailed below are the comments made by President Stephen. Note, these have to be ratified by the RI Board. If you would like to see further details go to: http://www.rotary.org/newsroom/events/070501 col wrapup.html.

At the recent Council on Legislation in April some 336 proposals were considered, of these 96 were accepted, 14 were referred to the RI Board, 71 were withdrawn and 155 were rejected; and from my recollections, this year's 29% acceptance rate is high compared to previous Councils on Legislation. The following proposals were among those accepted:

- A requirement for members to attend 50% of regular meetings in each half of the Rotary year.
- Amendments to the provisions for calculating attendance records.
- Inclusion of the Four Avenues of Service in the Standard Rotary Club Constitution.
- Authorising the RI Board to suspend or terminate a club that fails to investigate an allegation that a member violated youth protection laws.
- Clarification of the terms of the president-nominee and president-elect.
- A provision that the president shall continue to serve until a successor who has attended the presidents-elect training seminar and district assembly has been elected.
- An amendment to the provisions for qualification for membership.
- Allowing Rotary Foundation alumni to be active members.
- An amendment to the classification provision for termination of membership.
- An amendment to the provisions for termination for non-attendance.
- Allowing clubs to temporarily suspend membership during termination proceedings.
- The endorsement and affirmation that the eradication of polio is a goal of the highest order of Rotary International.
- A request to the RI Board to consider focusing on safe drinking water and endorsing the Blue Planet Run Foundation's Blue Planet Run and Water Project Activities.

- A request to the RI Board to consider proposing legislation to the next Council on Legislation to mention the Rotary Emblem and Service Above Self in the RI Constitution.
- A request to the RI Board to consider amending the RI secondary motto.
- A request to the RI Board to consider organizing a world contest to compose a new Rotary anthem.
- Endorsement of the mission, motto, and priorities of the Future Vision Plan for The Rotary Foundation.
- A request to The Rotary Foundation Trustees to consider allowing districts to access up to 30% of their District Designated Funds to be used for District Simplified Grants, reducing the minimum amount for Matching Grants to US\$2,500, and authorizing the construction of buildings using Matching Grants.
- A provision for settlement of disputes between Rotarians.
- A request to the RI Board to consider finding more efficient and less expensive ways to communicate with Rotary clubs.
- To provide that club and district websites shall include a link to the Rotary Worldwide Web.
- To request the RI Board to consider providing Internet software and platforms to be used by clubs.
- Revision of the qualifications for governor-nominee, the date by which a district must select the governor-nominee, and amendment to the provisions regarding the selection of the governor-nominee and special elections for governor.
- An increase in per capita dues.
- Authoring the RI Board to suspend a club that fails to pay its financial obligation to RI or the district fund.
- A requirement that the RI Board announce the results for deliberations on adopted resolutions.
- Clarification of voting procedures at district conferences.

Many of these legislated changes affect clubs directly and so will need to be included in our club's constitution when in due course we adopt the revised standard Rotary constitution as all clubs are required to do.
