President's Announcements

- 1. Thankyou to Rotarians who came out to DIK around last Saturday. It was a good day with much achieved, made even better by an excellent lunch provided by Rose Howland and her mates. The club will be sending at least one large container of educational supplies of various types to the Philippines this year.
- 2. You will hear about this and other interesting things at the club assembly in two week's time. Committee chairs are asked to prepare short and punchy presentations so that we can all find out where the club is up to in achieving this year's programme. This will be a great evening and you really must be here. I missed one earlier this year and ended up being President. If you don't want that to happen to you, make sure you're here.
- 3. At the Club Assembly we will also be discussing updating our Constitution and Bylaws. My proposal is that we adopt the standard bylaws but this would require some minor adjustments to our current arrangements. Next week I will provide a short paper about the differences for consideration ahead of the Assembly. Please be assured that this will NOT be the formal acceptance of the new Constitution and Bylaws.

John Peacham: Thanked members for the good turnout to the Donations in Kind project last Saturday to help with the loading of containers of books, desks, chairs etc to the Philippines. John particularly thanked Rose and Geoff Howland and the Philippine Community Ladies for catering.

Guest Speaker - David McLeod

David McLeod, the Brother of Greg, was introduced by Past President Stephen Westgarth. David explained how USA are occupying part of Cuba. In 1898 a war was fought between the Spanish, the then occupiers of Cuba, and the USA. When the war suddenly ended, part of the peace settlement was a leaseback arrangement of 45 square miles by the Spaniards to the USA.

David went on to explain his great difficulty in the initial stages of his appointment to understand the politics of David Hick's case.

- 1. Established he was not a prisoner but an unprivileged belligerent (a US invention)
- 2. Understanding the USA court marshal system
- Three charges were laid by USA government conspiracy, attempted murder or aiding the enemy
- 4. Civil actions in USA in the local courts were laid on behalf of David Hicks
- 5. David McLeod had to determine what did the USA and Australian Governments agree upon on war torture conventions

- 6. David McLeod had to understand and deal with "Fair go For David Hicks" pressure group's campaign in Australia
- 7. What did the press at large want to know about Hicks?
- 8. A huge workload of 25 hours a day.
- 9. How were David McLeod and his firm were to be paid; David's firm Lempriere Abbot McLeod wrote of approx \$300,000 in costs.
- 10. Convincing Prime Minister Howard, Foreign Minister Downer and Attorney General Ruddock that they must give David Hicks a fair go. The Australian government did not support Hicks as they should have under the Geneva Convention and order a fair trial.

Well-known international QC's including Geoffrey Robertson were engaged and donated their time to give David Hicks a fair trial.

Thank you David for giving us your better insight into the situation than was reported through our media.
