President Jerry's Announcements

It's My Own Work - PP Greg McLeod

Unley Rotarian and Past President Greg McLeod gave us a rundown on his work as a legal practitioner. One of four partners in the medium-sized law firm of Lempriere Abbott McLeod (LAM), Greg has practised law for over 30 years, all of that time with the same firm. He and his partners have also worked together in the firm for all of that time. LAM's offices are located "close to pub, deli and, of course, the courts." The firm has particular expertise in family law, commercial areas, international law and in Greg's practice in the areas of wills, estates and conveyancing, which forms a very reliable part of the firm's business. Greg is mainly involved in non-litigious matters and estate claims; while his partners cover the other areas of the practice.

He gave a strong recommendation (plug?) for people to have their wills prepared by a solicitor to ensure that there is no ambiguity and that the testator's wishes are correctly expressed; recovering from problems arising from a poorly drafted will can be costly compared to the "modest" fee charged by a solicitor. Greg made a plea that everyone have a will prepared and kept up to date and went on to recommend having Powers of Attorney and Enduring Power of Guardianship in place to enable someone to care for our financial, legal and medical needs should we lose the capacity to do it ourselves.

Greg described the sense of fulfilment he feels when matters are settled and completed and, where disputation is involved, preferably achieving resolution through compromise rather than litigation, which can cost a great deal of time and money. He is now seeing his third generation of clients, which enhances his feeling of being a "families" lawyer.

Greg described how South Australia has an independent bar rather than a fused bar where solicitors can appear in court. The rank of QC has now been replaced by the title of SC (Senior Counsel). Otherwise, Greg said, there have been no recent "stellar changes" in the legal system.

Thank you Greg for a comprehensive briefing on your work as a lawyer.

Guest Speaker - Danny Zaloumis: "SAPOL STAR Group"



Colin Schirmer introduced Brevet Sergeant Danny Zaloumis of the South Australia Police STAR Group. Brevet Sergeant is a new rank given to Senior Constables with special skills, training and expertise. Danny is 38 years of age, has four children under the age of 12 and was educated at Concordia College and Urrbrae Agricultural High School. He moved to Zambia for a number of years to work on his father's ranch and after returning to South Australia he joined the SA Police. After 9-10 years working general patrols in the Unley and Payneham areas he joined the Special Tasks and Rescue (STAR) Group, which is stationed at Netley. He has been with the STAR Group for nine years and his speciality is Police Marksman.

Danny began by playing a promotional video used to attract applications to join STAR Group from among the members of SAPOL, then presented a slide show to illustrate his talk. The Special Tasks and rescue Group (S.T.A.R. Group) is tasked with the provision of mobile patrol personnel skilled in the use of firearms, anti-terrorist tactics, crowd control, crime prevention techniques, and underwater recovery and search and rescue operations. The **STAR Group** comprises seven different sections:

Operations Section, of which Danny is part, is responsible for a myriad of tasks including high risk policing, counter terrorist response, search and rescue operations and the supplementation of general duty patrols.

The Water Operations Unit is responsible for policing the costal and inland waters of South Australia and provides the capability for search and rescue in those waters. There are five vessels varying from a five metre inflatable dinghy to a 16 metre Launch. The vessels are also used as diving platforms for police divers. The divers assist local police in the recovery of bodies or submerged objects from the sea, inland waters and caves. All water responses (sea search and rescue, water policing, diving, and Marine Crime Watch) are conducted by this Unit.

The **South Australia Mounted Police** is an integral part of today's policing strategies, unique in its contribution to the maintenance of law and order. Apart from the highly visible roles of escort duties and mounted patrols, there are many ways the Mounted Operations Unit contributes to the safety of the people. Imposing as they are, the non-aggressive presence of the horse enables mounted officers to safely and quickly defuse violent or antisocial situations, quite often without the hostility usually directed at other officers in similar circumstances.

The **Dog Operations Unit** provides support to operational police through the deployment of highly trained dog teams. Each team comprises a trained dog, being either a German Shepherd or Labrador retriever dog and handler. These dog teams are based in metropolitan Adelaide but are able to respond to calls for assistance

throughout the State. Police dog teams are trained to carry out duties involving tracking, searching, criminal apprehension, drug detection and explosive detection. The Dog Operations Unit is on call 24 hours a day, seven days a week.

The **Explosives Coordination Unit** is responsible for disposing of improvised explosive devices (IED) and /or explosive material, disposing of commercial explosives, clearing explosives from safes, clearing explosives scenes before post-blast examination, advising members of the public on measures to counter bomb threats, conducting high-risk searches for bombs, explosives, booby traps etc., maintaining a credibility to respond, as required, to all terrorist incidents and coordinating responses for military ordnance.

The **Negotiation Coordinator Section** provides support to operational police by deployment of trained negotiators throughout the State. Under the National Guidelines, negotiation is considered the first option to achieve a peaceful resolution in high-risk incidents and negotiators respond to all types of incidents where their expertise may be of assistance.

Training & Development Section provides training support to all sections in addition to the training undertaken by each section. During the course of his talk Danny related some of his own experiences in STAR Group and then answered a number of questions.

One of the key decisions was to set the annual fees for the coming year and it was agreed that we would increase half yearly dues to \$100, an increase of \$10. We have not had an increase for some time and the club needs to fund our normal activities and cover the dues to RI, etc. Ken Haines, in Lindsay England's absence, will be putting together an analysis of the monies we collect, how they are spent and presenting this to the club sometime in the next two weeks.

On a different note, we have been banging the drum on membership and this has been a focus, not only for us, but also for our District and for Rotary International generally. "Everything was going fine," he said. "Then Harry had a heart attack and died on the 10th tee."


"Oh, that's awful!"
