**Chandra Sluggett** circulated information about the upcoming **Group Study Exchange team** visit from Colorado, USA (see Rotary News, below) and about the GSE program. We need help with vocational placements and, for the first time, vocational mentors for each of the GSE team members. Please let Chandra know if you can help.

**ROMAC** are seeking help with hosting two children and their carers in October/November 2009 for a minimum of three weeks; both parties speak English. One child is a vascular patient from the Solomon Islands and the other child has a life threatening problem requiring cranio-facial surgery and is from an Indian family in Dubai.

A sponsor club and host family is required to:

- · Look after the child and their carer on arrival.
- Arrange for them to attend the Adelaide Children's Hospital for tests prior to their operation.
- Provide accommodation, meals, etc. and transport to and from the hospital.
- Transport the carer to the hospital to visit the child, unless the carer can be accommodated at the hospital during this time.
- Provide home hosting for the carer and child after discharge from the hospital.
- Arrange for transport for any follow-up checks or treatment until they leave Australia.

The estimated cost to host families is \$120 per week; a small payment is offered to help offset costs. The Unley club's International Committee may be able to assist financially as well.

On Sunday we arrived to Sydney Airport and luckily we missed our flight to Adelaide. There was a lovely Rotarian couple who booked us new flights and took us to see Sydney. We saw the opera house and the Sydney Harbour Bridge. Finally I arrived to Adelaide about 4pm. At the airport I met my lovely host Mum Joan and her daughter Catherine, Catherine's boyfriend John and the club president Jerry.

That night we had Jerry and Jenn for tea and Noni aka Mavis also came to see me. I was so exhausted about the travelling that I missed out on dessert. I had a big sleep, about 12 hours.

On Monday Joan and I went up to the hills and had a look over Adelaide and then we drove around seeing places. Joan's cousins from Victoria, Anne and Colin had a quick stay with us on their way to Darwin. On Tuesday we went shopping for school stuff. I got my first lunch box and school uniform - yay!! ## Guest Speaker - David Pisoni MP: "The State of State Education"

Introduction: Chairperson Wendy Andrews introduced Honorary Member David Pisoni MP to speak on "The State of State Education". David is the State Member for Unley. He was born and raised in South Australia. At age 21 after completing a furnishing trade's apprenticeship he started his own business. Over 22 years, David grew his business to be a successful manufacturing import/export and retailing company and trained 20 apprentices.

Prior to entering the Parliament David was involved with many Business/community groups, including the Unley Chamber of Commerce, the Unley Main Street Association, the Board of the Women's and Children's Hospital and the National Furnishing Industries Association.

On 18 March 2006 David was elected to the South Australian Parliament as Member for the State Seat of Unley. After 12 months on the back bench David was elevated to shadow cabinet and last year David was appointed Shadow Minister for Education and Shadow Minister for Employment, Training and Further Education, and Early Childhood Development. David also serves on the Parliamentary Public Works Committee.

David is married and has two school-aged children. His interests include furniture, design, food, wine and travel.

**David Pisoni:** 2009\_will be an important and challenging year for South Australia. The State Labor Government and Premier Rann will be doing their best to 'spin' you all towards reelecting them. Using the Hawker Britton model Mike Rann will be seen with winners and the famous, diligently avoid bad news or those who deliver it, reappear at good news announcements and pluck figures out of the air in the hope that you won't check them.

In terms of education, targets achieved under the Strategic Plan will be trumpeted by a beaming premier. Where these targets seem unlikely to be reached, they will simply be readjusted to make them fit the agenda or even deleted completely. Of course we in the Liberal Opposition will be doing the opposite, we will be appealing to your better judgment and presenting the substance and vision of a Liberal Government under Isobel Redmond, the first woman to lead a major political party in SA history.

The Rann government began 2008 in dispute with state school teachers and ended the year no closer to a resolution. Mid way through 2009 the Labor government is still in dispute with teachers and arbitration continues - the issue is far from resolved. In terms of public education South Australian families are no more certain of an end to disruption, rallies and a continuing lack of government leadership in education than they were in 2008.

In terms of teachers pay the Rann government's lack of fiscal discipline has conspired with the current economic environment to leave Labor with very little room to move. Successive Industrial Relations Ministers have failed to have any impact and chart a way forward. The Education Minister, astoundingly, has taken almost no interest at all. The teacher's dispute, it appears, is not her responsibility. She spends much of her time overseas. And unfortunately, despite his claim of being the 'Education Premier', the Rann and Foley team have increasingly applied their "rack 'em, pack em and stack 'em" approach to education as well as to the health and prison systems.

This has been most obvious in their approach to so called `Super Schools' (PPPs). The concept has been rejected overseas, notably in the United States, where there is a significant trend back to the advantages of smaller schools, particularly in less advantaged socioeconomic areas. The concept has also now been rejected by communities in Port Pirie, Whyalla and Port Augusta who recognised not

only the potential disadvantages for their communities but the rushed and thinly veiled asset grab and land sale that the proposals put to them ultimately were.

Spending on education as a proportion of the total budget has remained more or less static since 2002 under Labor, with additional spending cuts of \$25 million to be implemented over coming budgets. This was admitted by DECS CEO Chris Robinson during Estimates last year. This is on top of the \$153 million over four years ordered in the 2006-07 Budget. In the 2009 state budget Treasurer Foley has cut \$204 million from school programs and slashed capital funding by almost \$8 million or 12%, and electricity to 75% of 2001 figures by 2014.

Delivery of positive education outcomes in South Australia has become bogged down by a government unable to deal effectively with its education workforce, unwilling to adequately support its school leaders and a bureaucracy which micromanages the efforts of educators and school communities at the local level.

Education is not an area in which we can afford to cut corners or irresponsibly cut costs. However money is not necessarily the answer increased expenditure alone does not guarantee results if not accompanied by appropriate management, and in my opinion, higher expectations for our students, teachers and education administrators. The most effective path to success for all of us is through an education that equips us with the tools to reach our full potential. We should also be instructing and actively encouraging our children to be more entrepreneurial and to recognise opportunity not only in work and business - but in all aspects of their lives; this is important for a small state like SA. The public school system in particular has a responsibility to deliver the liberating advantage of a sound education to achieve an independent and better life.

As part of our ongoing policy development the Liberal Opposition has recently invited key stakeholders in the Education sector, as well as school Governing Councils to submit their views on Education in this state. However in reality the key issues are no mystery. In my role as Opposition Education spokesman I am approached on a daily basis by those involved in education, as well as parents and employers with their views and ideas. The main themes are recurring ones: Standards of numeracy and literacy, funding and funding, models, assessment methods, behaviour management - truancy, bullying and violence, infrastructure maintenance, curriculum, teaching standards, principal autonomy and the needs and increasing demands of school leadership, underperformance and lack of participation in maths and science (STEM) subjects.

This is of particular concern given the skills shortages in these areas of the job market and where we are steering our economy, zoning for secondary schools, school autonomy and decentralisation. As someone who is a strong supporter of public education and who has been involved on school Governing Councils including as a chair--- for a decade it is something in which I have a longstanding—and even pre-politics interest. I am a great believer in the positive benefits for educational outcomes of parental involvement and local governance in our schools.

In this I am of course consistent with the attitudes and reforms of previous state Liberal governments, in particular the Partnerships 21 policy which officially established and gave an expanded role to the school Governing Councils we have today. Unfortunately the Labor Party has not favoured decentralised school management. The independence promised by these former Liberal initiatives has been curtailed and more control of budgets and staffing arrangements has been given back to DECS, and the Unions. The Liberal party's view is that parents should be given the maximum choice and participation options to assist their children in making the most of their educational opportunities. Integrating parents with their children's learning is important. Parents and the local community should have a significant say in the running of their schools. Every school community is in its own way unique.

Some commentators have attributed much of the drift from government to non-government schools as occurring due to the real and perceived autonomy of these schools, particularly in relation to staff appointments and curriculum. SA has trained fewer engineers than any other state while the other states have grown their engineering graduate numbers. Currently around 34% of children in South Australia are educated in non-government schools. At Year 12 level that figure rises to 44%. The Independent and Catholic sector has a total of over 89,000 students, with over 42,000 in the Independent sector.

In the Education Minister's own seat of Adelaide over 60% of families choose the non-government sector as an education option for their children; examples of this are the Nailsworth and Prospect Primary Schools where 95% of parents seek alternative secondary schools to their in-zone high school. While the Liberal Party firmly believes in not only the rights of but advantages of choice in education there is a need to determine the reasons for dissatisfaction in many quarters for the education product offered by the public system. And not only this but to identify what our very successful public schools (such as Adelaide High, Brighton High) are doing right and expanding their formulas to other schools that are struggling.

We should not have a two-tier public education system. Government schools should set the benchmark for all three components of South Australia's education sector. On saying this I would like to point out that our state is very well serviced by the independent and Catholic school sectors. Politically it would be fair to say that those in the Non-government school sector have a right to feel let down by the Rann Labor Government - they are taking responsibility for more students yet have been receiving less funding. In terms of recurrent funding our non-government sector is the worst funded of any Australian state bar Victoria and currently languishes \$288 per student below the national average.

Like Abraham Lincoln I do not believe that, "you do not make the weak strong by making the strong weak." While listening to talkback radio last year I noted a comment from former South Australian Secondary Principals Association President Bob Heath. He said, "There is more central control of education by the bureaucracy in this state than there is in communist China." Given his extensive knowledge of school education in SA and having just returned from China at the time he was perhaps in a better position to make the call than most. However this same frustration at an over-centralised system, removed and unresponsive to the needs of individual schools, is often expressed to me and one I have had ample experience of myself as an active Governing Councilor. Principals in particular are continually frustrated by their lack of autonomy and the lack of support received for the increasing administrative and regulatory burdens imposed upon them by this bureaucracy.

My personal experience of Principals and the school leadership cadre in our state is that they are on the whole an impressive group, displaying high levels of experience, skill and dedication to their profession. However, as reported in The Advertiser today, their ranks are thinning and there is concern at the shortening queues to take their places as they retire. The Advertiser noted that senior principals are being brought out of retirement to fill the gaps. A future Liberal government is keen to implement more effective leadership development and succession planning to support our principals and the vital role they play in educational outcomes. The Liberal philosophy in terms of school governance remains that there will always be functions of the education system best achieved at a local as opposed to the centralised or bureaucratic level.

A Liberal view into the future would ideally see greater autonomy for Governing Councils and the opportunity for them to have as active a role as possible in those activities and decisions best undertaken at a local level. The role of DECS should be to provide the professional resources, technical support and supervisory functions best managed at a more centralised bureaucratic level. An

interesting and successful example of this philosophy in practice has been New Zealand's "Tomorrow's Schools" reforms initiated in 1989 wherein schools devolved administrative powers to local school communities and established community based Boards of Trustees, largely a parent representative body. The Board is a legally constituted crown entity directly responsible to the local community and the Ministry for effective management and delivery of education at their school. The Board's core roles include providing strategic leadership, developing a school 'charter' and to monitoring and standing accountable for student and the Principal's achievement levels. Student outcomes are now judged to have improved under this self-governance and management model. Of note, in 2001 the government changed the legislation to make student achievement a specific goal of the system.

In this element of the education debate it should be asked who is best placed to determine and act upon priorities in school policy, asset management and selection of staff----the answer to my mind is an informed and empowered local school community. The Liberal vision will remain to afford Principals and local school communities an expanded management and policy role and the ability to improve their student focus education outcomes. The fundamental role of South Australian schools is to provide our children with the tools needed for success in their personal, further study and employment futures. Our education challenge is to unlock our states potential. It is the responsibility of Government to open the door of education opportunity and to ensure our students, parents and educators are resourced, supported and encouraged to achieve their full potential. Our education system also needs the versatility to meet a fast growing demand for higher level skills in a global knowledge economy.

The Liberal Party education vision recognises that education is not only about providing the teachers, infrastructure, resources and innovation that our children and schools require---it is about supporting the communities that those schools are part of and service school communities.

Serious challenges lie ahead and this is not a time to drop our guard or to settle for second best in education. A State Liberal Government will maintain its strong commitment to choice and excellence in education to ensure the legacy our children deserve.

## The Group Study Exchange Program

What is Group Study Exchange? The Group Study Exchange (GSE) program of The Rotary Foundation of Rotary International is a unique cultural and vocational exchange opportunity for young business and professional men and women between the ages of 25 and 40 in the initial years of their professional life. The program provides travel grants for teams of participants to exchange visits between paired areas in different countries. For four to six weeks, team members study the host country's institutions and ways of life, observe their own vocations as practised abroad, develop personal and professional relationships, and exchange ideas. Team members can come from corporations, small businesses, community organisations, medical and educational facilities, government offices, and nonprofit agencies.

Benefits of Exchanges: Individuals who participate in this rewarding, once-in-a-lifetime experience return home with a broadened cultural perspective and new understanding of a nation's history, language, commerce, and government. A GSE offers a unique opportunity to develop leadership skills, work on team building, and increase self-confidence. The program is designed to have an invaluable impact on the career of a young professional in the increasingly global workplace by creating networking opportunities and lifelong friendships.

Benefits to Employers and the Community: GSE enhances the international perspective of the next generation of young leaders that will take your company into the future. GSE participants return with new communication and facilitation skills that promote tolerance and collaboration with professional people of other cultures. GSE fosters a creative approach to problem solving by expanding the employee's skill set, exposure to alternate methodologies, and preparation for addressing community needs. In addition, GSE provides a great public relations opportunity to promote awareness of your business or organization, as local and international media may feature interviews, photos, and articles about the exchange.

Who is Eligible? GSE team member applicants must:

- Be between the ages of 25 and 40
- Be fully employed with at least two years of work experience in their chosen field
- Be in the early stages of their careers or professions
- Reside in or be employed in the sending Rotary district and also be citizens of the country in which they reside

- Be proficient in the language of the country being visited
- Be personable, articulate, cooperative, motivated team players, and enthusiastic about their vocations
- Seek to gain a maximum educational value from the program, as well as be able to fulfill the rigorous demands of international travel and active participation in an extensive itinerary

The best candidates for GSE are rising leaders who meet the qualifications above and who have an interest in people of other cultures. GSE can be an excellent way to recognize top-performing staff or provide exposure for potential young leaders with limited international experience,

Note: Spouses of participants may not accompany teams. In addition, the following are ineligible: a Rotarian; an employee of a Rotary club, district, other Rotary entity, or Rotary International; any Rotarian's or Rotary employee's spouse, ancestor (parent or grandparent by blood), lineal descendant (child or grandchild by blood and any legally adopted child); or a spouse of a lineal descendant.

Structure of the Program: Teams are composed of 4-6 non-Rotarian team members, usually of various business and professional backgrounds, and one Rotarian Learn leader. The GSE experience spans 4-6 weeks. During the exchange, teams will visit local businesses, government offices, and community organizations in the host district, tour historical and cultural sites, stay with Rotarian host families, and make presentations about their host countries and professions. Team members receive orientation and cultural preparation from the sponsor Rotary district before their departure. This may include language training, practice of oral presentations, visits to Rotary clubs, and background about Rotary International's mission and the programs of its Foundation. The host country is determined before a team member's application and selection.

What is Provided? For each team member, The Rotary Foundation provides the most economical round-trip air ticker between the home and host countries. Local Rotarians in the host area provide for meals, lodging, and group travel in their district. Each team member is responsible for all personal and incidental expenses incurred before, during, and after the study tour, including any personal travel arranged after the exchange.

#### What is Required of Participants?

#### Before leaving:

• Participate in orientation sessions and group meetings, and obtain the necessary documents for traveling. This includes passport, travel visa, immunizations, and medical insurance.

#### During the tour:

- · Accept the decisions of the Rotarian team leader.
- Fulfill any requirements to speak at Rotary host district gatherings.
- Remain with the group throughout the study tour except when individual activities are planned.
- Maintain standards of behavior that will reflect positively on Rotary and the home Country.

#### After returning:

- Prepare and submit final reports of the tour as required by the sponsor district and T<sup>h</sup>e Rotary Foundation.
- Speak about your GSE experience to Rotary clubs and other groups.

**How do People Apply?** Applications must be made through local Rotary clubs; those sent directly to The Rotary Foundation will not be considered. Candidates are selected by a qualified committee of Rotarian leaders.

## Worth the smile of a healthy child

Amidst civil conflict, economic turmoil, and chronic shortages of just about everything, Analia Ramos has helped the people of South Sudan battle hunger for nearly a year as food security coordinator in Sudan for Concern Worldwide, a humanitarian relief and development organization.

A 2004-06 Rotary World Peace Fellow from Argentina, Ramos oversees projects that provide seeds and tools to poor households, establish seed banks and tree nurseries, and train people in agricultural plowing, beekeeping, and blacksmithing.

Ramos says the situation in South Sudan has deteriorated since she arrived last August. "Insecurity has grown, the economic crisis has hit us all, the violations to the Comprehensive Peace Agreement have multiplied," she says. "Add to that the indictment of President Bashir by the International Criminal Court, the expelling of 13 NGOs, and tribal conflict, and you have it all."

But Ramos says the knowledge that she is "helping to diminish the suffering of the people by shortening the hunger gap, and at times eliminating it," gives her great fulfillment. She maintains that freedom from hunger is a basic human right. "Without that, you cannot have health, education, or any other right," she says. "But with any right, we all have responsibilities. People need to learn how to fish and not just be given the fish. It is their right to be able to feed themselves."

Ramos knew at age seven that she wanted to be an agronomist and at age 12 that she wanted to work in Africa. Her fellowship experience at the University of Bradford was pivotal in shaping her career. "Rotary gave me a new angle," she says. "I saw how working in food security contributes to peace, to achieve human rights for most of the people who do not have a voice." Throughout history, Ramos says, hunger has claimed more lives than armed

conflict or disease. "Hunger is the No. 1 killer," she says. "But it only makes news in big famines, and people forget, in most cases, it is a silent killer."

In the face of frequent food shortages, Ramos tries to help in any way she can. "Trying is worth the smile of a child, the knowledge that someone has gone to bed not hungry, that God has been there all the way, even in the difficult times," she says.

#### Clinic takes aim at infant AIDS

Rotarian Stephen Nicholas, a pioneering pediatric AIDS specialist who helped drastically reduce infant HIV in New York City, is using Rotary as a catalyst for wiping out mother-to-child HIV transmission in the Dominican Republic.

In the early 1990s, New York City had the highest birth rate of HIV-infected children in the United States. Since 2000, only one baby in that city has been born with the virus, says Nicholas, a member of the Rotary Club of Yonkers. Similar trends are appearing throughout the United States, he adds. This sharp drop in mother-to-child HIV transmission has largely resulted from improvements in drug treatments as well as aggressive intervention during pregnancy through testing and education. Nicholas and his colleagues pioneered this multipronged approach while he was the director of pediatrics at Harlem Hospital Center.

"For me, the moral equation changed when I realized that infant AIDS was disappearing in the United States," says Nicholas, founder and director of Columbia University's International Family AIDS Program. "With a world filled with HIV/AIDS, I felt for the first time obligated to get involved internationally."

In 1999, Nicholas began a family AIDS clinic in La Romana, Dominican Republic, a province with one of the highest HIV/AIDS infection rates outside sub-Saharan Africa. Run by the International Family AIDS Program, the clinic provides direct care and treatment for pregnant women with HIV.

To expand the International Family AIDS Program and keep it sustainable, the Yonkers club, along with the Rotary Club of La Romana and District 7230 (New York), launched the Mother-Baby AIDS Project in the Dominican Republic in 2006.

With help from a US\$50,000 World Community Service Project Grant, the project is benefiting more than 100 HIV-infected mothers and their newborn babies each year. Infected mothers continue to receive AIDS treatment after the births to protect children from being orphaned. The clinic has lowered the rate of mother-to-child HIV transmission in the La Romana province from 40 percent to less than 1 percent, Nicholas says.
