RI Board reinforces strategic priorities, goals




At its November meeting, the RI Board approved a number of recommendations and actions to reinforce the priorities and goals of the RI Strategic Plan. The changes, which include endorsing the concept of flexible attendance and meeting requirements and allocating US\$4 million for Public Relations Grants, are designed to keep Rotary vibrant and attractive to current members and prospective members from younger generations.

"By focusing on strategic issues throughout the week, the Board was able to reach consensus on several strategic decisions, which constitute progressive moves by the RI Board," says RI President Ray Klinginsmith.

Among other actions, the Board

- Agreed to the concept of amending RI policy on meeting attendance, meeting options, and member termination in order to support and strengthen clubs by allowing them more flexibility. The changes will require revisions to the RI Constitution and the Standard Rotary Club Constitution in the form of legislation submitted to the 2013 Council on Legislation.
- Agreed to fund US\$4 million in PR grants annually, starting in 2011-12 for at least three years, to advance the strategic priority of enhancing public image and awareness.
- Supported the creation of an annual Rotary Citation beginning in 2012-13 that would replace future Presidential Citations. The new citation would be based on clubs achieving predetermined goals that are aligned with the clubs' and RI's strategic direction.





- Agreed to conduct four new pilot programs -- associate member, corporate member, satellite clubs, and innovative and flexible Rotary clubs -- to promote membership diversity and improve recruitment, beginning 1 July. Two hundred clubs will be accepted for each three-year pilot.
- Encouraged districts with more than 100 clubs and over 4,000 members to split into two or three new districts as early as 1 July 2012.

The Strategic Planning Committee suggested many of the changes to help move the organization toward an emphasis on active and engaged membership.

"Rotary must change its culture from one of attendance to one of engagement," says RI Director Stuart B. Heal, chair of the Strategic Planning Committee. "It is our belief that in the next decade this must become our culture as we become more innovative and continue serving around the world."

Said Ray Klinginsmith: "It was a historic week for Rotary."

The Family of Rotary

December is Family Month. To many Rotarians, the family of Rotary means spouses, brothers, sisters, parents, and children. Their work for Rotary is very much appreciated. However, to me, as long as we do not have a Rotary family membership, relatives are not the family of Rotary – the family of Rotary consists of all Rotary International districts, clubs, Rotarians, programs, and The Rotary Foundation.

The Rotary Foundation is a huge part of the family of Rotary. All of the money raised, whether through Rotary International or The Rotary Foundation, is channeled through The Rotary Foundation. There are large sums of money coming every year to the Annual Programs Fund, the Permanent Fund, the Rotary Peace Centers Major Gifts Initiative and, right now, Rotary's USD200 Million Challenge.

Even though the money-raising efforts for these four funds are separate, they are all linked together. Annual giving is the core of our business. The Permanent Fund was geared toward those Rotarians who can afford to give large sums and as a support to the Annual Programs Fund. The Rotary Peace Centers Major Gifts Initiative was also launched to approach those Rotarians who can afford to give more than average. Thus it is apparent how these three fundraising events depend on one another. In addition we have Rotary's USD200 Million Challenge, which affects the annual giving, thus also the two other fundraising programs.

It is important that when we give money, we must donate to all of the above initiatives. By remembering this, we can continue *Building Communities* — *Bridging Continents* through Service Above Self.
