

Screening and background checks

Changes to the National Screening
Youth Exchange Programs

The Screening Unit introduced new Informed Consent Forms on 12 August 2013. The advertised transition period, and a further three week grace period, expired on 30th August 2013. After Monday 2 September 2013, the Screening Unit WILL NO LONGER PROCESS applications for any form of screening received on the old application forms. All OLD application forms received after this time will be returned.

On 29th November, Rebecca Fuss, Manager, International Exchanges and Accreditation. Department for Education and Child

Development (DECD) wrote to Rotary Youth Exchange (RYE) Chair Mark Martin and informed him of the new DECD requirements for Criminal History Screenings (Working with Children Checks) for the International Secondary Student Exchange Program.

Effective immediately, all Counsellors and Host Families who do not have a current "National Police check" and who will be hosting an exchange student are required to apply on line under the new guidelines. The new application process will incur a fee, albeit reduced of \$37.50 (GST may apply).

These changes that the Screening Unit has undergone were undertaken to ensure compliance with a range of legislative, regulatory and intergovernmental obligations. Importantly among these is the Screening Unit's participation in the National Exchange of Criminal History Information for People Working with Children (ECHIPWC). Screening is an assessment of information obtained about you to determine whether you may pose a risk to a particular group of people in a professional or volunteer environment.

The Department for Communities and Social Inclusion (DCSI) Screening Unit is authorised under the Children's Protection Regulations 2010 (PDF 68KB) to conduct Child-Related Employment Screening for people who work or volunteer with children and young people. More information about who-is required to-undergo child-related employment screening.

Australians commemorate 25 April 1915 as 'Anzac Day'. It was the day of the 'Landing at Gallipoli' when more than 20,000 Australians and New Zealanders and some servicemen from other countries went ashore at the Gallipoli Peninsula. They fought the soldiers of the Ottoman Army, mainly up on the ridges well beyond the beaches. The first group ashore landed at dawn; they were the so-called 'covering force' whose task was to drive the Turkish defenders into the hills. After that the main force would come ashore.

At the recent **Rotary Youth Exchange** Australia national conference, a representative of DGE Korhan Atilla from D2430 in Turkey submitted a proposal for Australian Districts to consider an exchange to acknowledge the 100 year anniversary of the ANZACs in 2015. That would see both the ANZ and Turkish students being on their exchange on April 25th 2015.
