INVITATION to CLUBS - D9520 District Simplified Grants 2012/2013

The Rotary Foundation (TRF) makes available each year a sum of money to the District for Simplified Grants. The sum available to the District is determined by the amounts Clubs donate to the TRF Annual Programs Fund 3 years ago. Therefore, the sum available each year varies.

These grants funds are for humanitarian projects at local or international levels. All Clubs are now invited to apply, by 21st October 2012. Amount available – up to \$1,500

- 1. How to Apply: Send a letter 1-2 page in length. It is a competitive process. That is, each Club will be competing against each other for the funds. Please consider using the following questions as a guide to give your application the best chance of success.
 - 1.1 Describe the project What would be done? Where would this project take place?
 - **1.2** Humanitarian need Who would benefit from your project and how would this project impact on their lives? How many people would benefit from this project?
 - **1.3** Rotarian and non-Rotarian involvement How many Rotarians would be involved in this project and what would they do (other than financial contribution)? Would non-Rotarians or other organisation be involved in this project and what would they do?
 - **1.4** Completion date when would this project be completed? It must be completed by 30 JUNE 2013 if not, you may have to return any unspent funds to District.
 - 1.5 Reporting Who would be responsible for submitting the final report to the District please provide their contact details? The final report (TRF Individual Project Report Form) must be submitted to the District by 30 JUNE 2013.
 - **1.6** Costs of the project How much are you seeking from the District?

Eligibility Criteria & other information:

- **1.7** TRF Humanitarian Grants Program, Eligibility Guidelines will be used to assess eligibility of your project see below (page 2). If you are unsure please contact Chandra Sluggett for assistance or submit your application in any case.
- **1.8** The DSG funds cannot be donated to any organisation. Where the grant funds are for purchase of goods, Clubs are encouraged buy and donate the bought goods.
- 1.9 Rotary Clubs which currently have overdue District Simplified Grant report due would not be considered until the final report for 2011/12 year is submitted.

TRF Humanitarian Grants Program - Eligibility Guidelines for projects

Incorporation of Rotary Clubs and Projects

With the Council on Legislation coming up in April 2013, and with some clubs still updating their constitutions from the last COL in 2010, please remember that if a club is wanting to be, or already is, incorporated they MUST include the following clauses:

- 1. The name of this corporation shall be "Rotary Club of _____(full official name)_____,Incorporated." [Country may be omitted]
- 2. This corporation shall be a non-profit corporation. Its purpose shall be charitable and benevolent and to encourage, promote and extend the object of Rotary International, and to maintain the relations of a member club in Rotary International.
- 3. Insofar as the provisions of the law of the State/Province of _____ under which this corporation is incorporated shall permit, this corporation shall be subject to the jurisdiction of Rotary International.

The last two clauses should be placed after Article 19 in the current Standard Rotary Club Constitution, to form clauses 20 and 21.

The requirement that the SRCC not be changed only relates to unincorporated Rotary Clubs. If they wish to be incorporated these two clauses must be added. Any further clauses that are required by local law should be placed after clause 21.

All clubs must seek Rotary International approval prior to submitting their documents to the relevant Government Department.

Once approval is given, the club will be supplied with a letter of approval to be presented to the Government Department, indicating that we have no objection to the use of the Rotary Marks in the name of the club being registered.

Any Rotary Club or District Foundations, or project names that contain the Rotary Marks (including the word 'Rotary') must be submitted to this office for approval prior to registration.
